There will be a \$35 scratch fee collection for each dog after the draw has been made if the above criteria has not been met. No refunds will be made after the draw unless notification is given directly to the Hunt Test Secretary prior to the start of the Test (8 a.m.).

Directions to Madison Retriever Club Grounds – Club House
Rutland-Dunn Townline Road at Labrador Road – Hook Lake - Oregon, WI

From the South – Chicago, IL

Take I-39 N/US-51 Towards Rockford, IL. Follow I-90 W/US-51N Signs towards WISCONSIN

Approximately 15 to 20 minutes north of Janesville, Wisconsin: Take Exit #156 – US-51 North to STOUGHTON. You are now approximately 10 miles from the Club Grounds.

After passing through Stoughton, you will pass the STARK AUTO DEALERSHIP on your left and a Culver's on your right. Rutland-Dunn Townline Rd is 1/2 mi ahead. Turn left onto Rutland-Dunn Townline Rd (stay left at the first Y), proceed 4 mi to Labrador Rd. Turn right onto Labrador Rd. (you will see the "Madison Retriever Club" sign at this turnoff.) The Club House is at the end of this road.

From the Oshkosh/Green Bay Area

US-45 South to US-41 South - Follow US-41 South to WI Hwy 26 near Waupun
Take Hwy 26 to Hwy 151 South

Approaching Madison, Exit to I90 East/I-94 – Exit 97A towards Janesville - Merge onto I90 East

Take Hwy 12 West/US-18 West Exit, #142A towards Madison, Merge onto Hwy 12 West

Take the first exit, US-51/Stoughton Rd Exit #266. Turn left onto Hwy 51 South
Follow Hwy 51 through McFarland

You will travel approximately 5 to 6 miles to Rutland Dunn Townline Rd.
(Pass Hwy B on your LEFT with the First National Bank of Stoughton on the left..... you take the next RIGHT turn onto Rutland Dunn.)

Travel 4 miles to Labrador Rd. (stay left at the first Y). Turn right onto Labrador Rd. (you will also see the "Madison Retriever Club" sign at this turnoff.) The Club House is at the end of this road.

From the Minneapolis Area

I90 East/I-94 towards Madison

The exit is the last Madison exit - it is the exit after Hwy 30. Hwy 30 goes right into Madison and I94 splits to the left towards Milwaukee. Stay on I90 following the "Chicago" sign at the split.

Take Hwy 12 West/US-18 West Exit, #142A towards Madison. Merge onto Hwy 12 West

Take the first exit, US-51/Stoughton Rd Exit #266. Turn left onto Hwy 51 South
Follow Hwy 51 through McFarland

You will travel approximately 5 to 6 miles to Rutland Dunn Townline Rd.
(Pass Hwy B on your LEFT with the First National Bank of Stoughton on the left..... you take the next RIGHT turn onto Rutland Dunn.)
